

MONO Creators LLC, a limited liability company organized and existing under and by virtue of Section 17710.01 et seq. of the California Revised Uniform Limited Liability Company Act (the "California Act"), does hereby certify:

**FIRST:** That MONO Creators LLC was originally formed on January 12, 2007, in the State of California.

**SECOND:** That the name of the limited liability company immediately prior to the filing of this Certificate is MONO Creators LLC.

**THIRD:** That MONO Creators LLC does now desire to convert from a limited liability company to a corporation, pursuant to Section 265 of the General Corporation Law of the State of Delaware, to be named MONO Creators Inc., as set forth in the Certificate of Incorporation filed with the Office of the Secretary of State of the State of Delaware contemporaneously herewith.

**FOURTH:** That, immediately upon the filing of (a) this Certificate of Conversion, and (b) the Certificate of Incorporation of MONO Creators Inc. with the Office of the Secretary of State of the State of Delaware, each outstanding one percent (1%) membership interest of MONO Creators LLC, and all rights in respect thereof, shall, without any further action on the part of anyone, be canceled and extinguished and be converted into and represent One Hundred Thousand (100,000) shares of MONO Creators Inc. common stock, par value \$0.0001 per share. No other cash, shares, securities or obligations will be distributed or issued upon conversion of the membership interests of MONO Creators LLC.

**FIFTH:** That the future effective date shall be January 1, 2015, for the filing of (a) this Certificate of Conversion, and (b) the Certificate of Incorporation of MONO Creators Inc. with the Office of the Secretary of State of the State of Delaware.
