## ASSIGNMENT OF PATENT RIGHTS

- (d) foreign patents, patent applications and counterparts claiming priority from any item in the foregoing categories (a) through (c), including, without limitation, certificates of invention, utility models, industrial design protection, design patent protection, and other governmental grants or issuances
- (e) causes of action (whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patents and/or the rights in categories (a) through (d) above, including, without limitation, all causes of action and other enforcement rights for (i) past and future damages, (ii) injunctive relief, and (iii) any other remedies of any kind for past, current and future infringement; and
- (f) rights to collect past and future royalties or other payments for a license under or on account of any of the Patents and/or any of the foregoing, other than as agreed upon between the parties.

Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or issuances that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.


