**AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF**

**EMERSON NETWORK POWER - EMBEDDED COMPUTING, INC.**

Pursuant to Chapter 180 of the Wisconsin Statutes, the Articles of Incorporation of Emerson Network Power-Embedded Computing, Inc. (hereinafter called the "Corporation") are hereby amended and restated in their entirety, and these restated Articles supersede and take the place of the existing Articles of Incorporation and any amendments thereto, as set forth below:

**ARTICLE I  
NAME**

The name of the corporation is Artesyn Embedded Computing, Inc.

**ARTICLE II  
ORGANIZING LAW AND PURPOSE**

The Corporation is organized under Chapter 180 of the Wisconsin Statutes for the purpose of engaging in any lawful activity within the purposes for which corporations may be organized under the Wisconsin Statutes.

**ARTICLE III  
CAPITAL STOCK**

The number of shares of stock that the Corporation is authorized to issue is Nine Thousand (9,000) shares, par value \$0.01 per share, of common stock (the "Common Stock"). Each issued and outstanding share of Common Stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders of the Corporation.

**ARTICLE IV  
REGISTERED OFFICE AND AGENT**

The address of the registered office of the Corporation in the State of Wisconsin is 8040 Excelsior Drive, Suite 200, Madison, Wisconsin 53717. The name of the Corporation's registered agent at such address is C T Corporation System.

**ARTICLE V  
PRINCIPAL OFFICE**

The principal office and mailing address of the Corporation is 5810 Van Allen Way, Carlsbad, CA, 92008, or any other location as the Board of Directors may from time to time determine or the business of the corporation may require.
