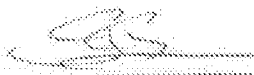
ASSIGNMENT

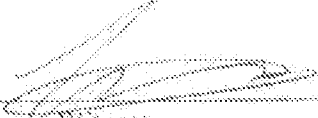

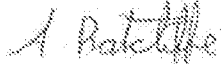
