(6.) I, the Assignor, hereby authorize and request the Commissioner of Patents and Trademarks, and all similarly situated foreign officials, to issue any and all Letters Patent(s) resulting from said application(s), regardless of the form of said application(s), to said Assignee, as Assignee of the entire right, title, and interest in and to the same for the Assignee's sole use, benefit, and behoove, and for the use and behoove of Assignee's legal representatives, to the full end of the term for which said Patent(s) may be granted, as fully and entirely as the same would have been held by the Assignor had this Assignment and sale not been made.

(7.) I, the Assignor, hereby covenant that I have full right to convey the entire interest herein assigned and sold, and that I have not executed, and will not execute, any agreement(s) in conflict herewith.
