TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT (this "Termination"), is dated as of November 23, 2015, and made by **COMPASS HORIZON FUNDING COMPANY LLC**, ("Lender") to **COURION CORPORATION**, a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Grant of Security Interest Patents dated as of February 17, 2011, made by Grantor in favor of Lender (as amended to date and together with all schedules thereto, the "Security Agreement"), a security interest was granted by the Grantor to Lender in certain collateral, including the Patents (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on December 17, 2011, at Reel 25856 and Frame 991; and

WHEREAS, Lender now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Lender hereby states as follows:

1. Definitions. The term "Patents Collateral", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature in, to and under the following:

(a) all of Grantor's patents, patent applications, patentable inventions, trade secrets, equipment formulations, manufacturing procedures, quality control procedures, including those listed on Schedule A hereto (collectively, "Patents") and licenses for any of the foregoing ("Licenses");

(b) all reissues, continuations, continuations-in-part, substitutes, extensions or renewals of and improvements on the foregoing; and

(c) all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement of any Patent or any Patent licensed under any License.


2. Release of Security Interest. Lender hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Patents and the other Patent Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Lender in and to the Patent Collateral. Lender authorizes the Grantor and its designees to file this Termination with the United States Patent and Trademark Office.
