ASSIGNMENT and DECLARATION

UNITED STATES PATENT APPLICATION

WHEREAS, We, Michel Herrmann of 29 Quai Jean Baptiste Simon, 69270, Fontaines Sur Saone, France, Philippe Gaubert of 11 rue des Maraichers, 69680, Chassieu, France and Damien Bouchet of 9, rue de la Roussiere, 69970, Chaponnay, France (the "Assignors") have invented certain new and useful improvements in a HEDDLE FOR A LOOM AND LOOM EQUIPPED WITH SUCH A HEDDLE (the "Invention") for which I have made an application for patent of the United States identified as application no. 14/876,916 (the "Application"), filed October 7, 2015.


Now, for and in consideration of a sum of Ten Euros (EUR), in hand paid to us, and other good and valuable consideration, the receipt of which we hereby acknowledge, we hereby assign, sell, and transfer to the Assignee the entire right, title, and interest in and to the Invention and Application for patent of the United States, and in and to all non-provisional applications for patent of the United States claiming priority to the Application, such as continuing applications including divisional applications, and in and to any patent of the United States and all reissues and extensions thereof that may be granted, together with the right to extend the protection for the patent to the various territorial possessions now owned or which may be hereafter acquired by the United States of America, together with all rights of priority granted by local laws and treaties including any international convention, for the protection of industrial property, all rights conveyed herein to be held and enjoyed by the Assignee for its own use and behoof, and for the use and behoof of its successors or assigns, to the full end of the term for which any patent or industrial property right for the Invention is enforceable, as fully and entirely as the same would have been held and enjoyed by me if this assignment had not been made. I do hereby request and authorize that any and all patent and any and all industrial property right, when granted, be issued in accordance with this assignment to the Assignee.

WHEREAS, In further consideration of the sum of Ten Euros (EUR), and the other good and valuable consideration, to us paid, we covenant and agree with the Assignee that it has a full and unencumbered title to the Invention and Application hereby assigned, which title we warrant unto the Assignee, and we further agree that we will, without demanding any further consideration therefor, at the request but at the expense of the Assignee, do all lawful and just acts, including executing and acknowledging instruments, furnishing information, and giving testimony that may be or become necessary for obtaining, sustaining, or reissuing a United States patent, and for maintaining and perfecting the Assignee's right to the Invention and any patent and industrial property right granted for the Invention, such as in cases of interference, derivation, an administrative trial proceeding before the United States Patent and Trademark Office, and litigation.


