Assignor hereby authorizes Assignee to file patent applications in all countries for any or all of said Invention(s) in Assignor's name, or in Assignee's name, or otherwise as Assignee may deem advisable, under any international or bilateral treaty, agreement or convention, or otherwise.

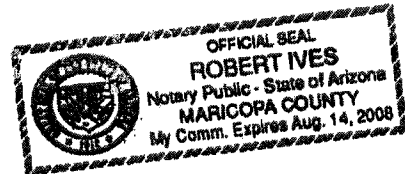
