INTANGIBLES TRANSFER AGREEMENT

THIS INTANGIBLES TRANSFER AGREEMENT (this "Agreement") effective as of June 10, 2015, (Effective date) is entered into by and between:

AB VOLVO, Corporate Registration Number 556012-5790, a corporation organized and existing under the laws of Sweden and having its corporate offices in Gothenburg, Sweden (hereinafter referred to as "ABV"),

and,

(also known as Volvo Truck Corporation)

VOLVO LASTVAGNAR AB, Corporate Registration Number 556013-9700, a corporation organized and existing under the laws of Sweden and having its corporate offices in Gothenburg, Sweden (hereinafter referred to as "VTC").

WHEREAS, ABV owns the patents, trademarks and design right set out in **Appendix A**, (hereinafter collectively referred to as the "INTANGIBLES");

WHEREAS, ABV is willing to transfer the legal and beneficial economic ownership of the INTANGIBLES, as of the effective date, to VTC at a price of ten (10) SEK per patent, trademark and design, and VTC is willing to purchase the INTANGIBLES in accordance with the terms and conditions hereof;

NOW THEREFORE, the Parties agree as follows.

1. As of the effective date of this Agreement, ABV hereby assigns, to VTC, ABV's entire right, title and interest in all the INTANGIBLES specified in **Appendix A**.
2. In exchange for the transfer of the INTANGIBLES, VTC shall pay to ABV a one-time payment of a price of ten (10) SEK per patent, trademark and design. VAT is applicable on the transfer and the total payment due to ABV from VTC, excluding VAT, for the INTANGIBLES is SEK 690.
3. The price of the INTANGIBLES shall be paid in SEK and be made through wire transfer by VTC to the bank account designated by ABV.
4. This Agreement shall be construed in accordance with, and governed by, the laws of Sweden, excluding its conflict of law principles.
