- (1) The Assignor is the Applicant for all designated states except the United States of America in relation to the International Applications set out in the Schedule hereto ("the Applications")
- (2) The Assignor has agreed to assign all its rights in the Applications and in the inventions which are the subject of the Applications ("the Inventions") to the Assignee for the consideration hereinafter mentioned

Operative provisions:

In pursuance of the said agreement and for the payment of £1.00 and other good and valuable consideration paid by the Assignee to the Assignor (the receipt and adequacy of which are hereby acknowledged by the Assignor):

1. the Assignor hereby ASSIGNS and transfers to the Assignee absolutely:
 - 1.1 all its rights title and interest in and to the Applications and the Inventions for all designated states and regions (including the United States of America) together with all rights and powers arising or accrued therefrom (including but not limited to European patent application Nos. 10736768.2 and 10736766.6);
 - 1.2 the right to apply for prosecute and obtain patent or other industrial property protection throughout the world in respect of the Inventions including the right to claim priority from the Applications or from any patent application from which priority is claimed in the Applications to the intent that the grant of any patents or other industrial property protection for the Inventions shall be in the name of and vest in the Assignee;

2. the Assignor undertakes that at the request and cost of the Assignee it will at all times hereafter do all such acts and execute all such documents as may be reasonably necessary or desirable both to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder (including without limitation all such documents as may be required by the Patent Offices of the designated states and regions once the Applications have entered national and regional processing) and to assist in the resolution of any question concerning the Applications or the Inventions.


