Further, I hereby covenant and agree to and with ARCHITECTURAL APPLICATIONS P.C., and its successors and assigns, at the time of execution and delivery of this document, that I am the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified patent application, and that the same are unencumbered, and that I have good and full right and lawful authority to sell and convey the same in the manner herein set forth.
