WHEREAS, Assignee desires to acquire any and all, right, title, and interest of Assignor in and to the Patent Rights.

NOW THEREFORE, for good and valuable consideration to Assignor, the receipt and sufficiency of which are hereby acknowledged, Assignor confirms that it has sold, assigned, and transferred and by these presents does hereby sell, assign and transfer to the said Assignee, and said Assignee's legal representatives, successors and assigns, any and all of the entire right, title and interest in and to the Patent Rights, *nunc pro tunc* effective as of 8/30/12.

Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Patent Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Patent Rights to a third party. Assignor further represents and warrants that it will, upon request, without further or additional consideration, but at the expense of the said Assignee, execute such additional assignments and other writings as may be necessary to perfect the Assignee's enjoyment of this grant, and execute acknowledgments of this assignment as necessary for full enjoyment of the Patent Rights and for recording in foreign patent offices.
