AND I/WE hereby authorize and request the patent granting authority in any foreign jurisdiction to issue any and all patents which may be granted upon said application or any of them, or upon said invention or any part thereof, to said ASSIGNEE;

AND I/WE hereby agree for myself and for my heirs, executors and administrators, to execute without further consideration any further lawful documents and any further assurances, and any provisional, non-provisional, divisional, continuing, reissue, or other applications for patents of any country, that may be deemed necessary by said ASSIGNEE fully to secure to said ASSIGNEE its interest as aforesaid in and to said invention or any part thereof, and in and to said several patents or any of them;
