**ASSIGNMENT AND AGREEMENT**

FOR VALUE RECEIVED, EBL ApS (hereinafter "assignor"), a Danish private company doing business at Slagkrogen 15, Odense SØ, Denmark does hereby sell, assign and transfer to Unibio A/S (hereinafter "assignee"), a public limited company duly organized and existing under the laws of Denmark, and having a principal place of business at Billedskærervej 8, 5230 Odense M, Denmark as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, **for all countries** in and to certain inventions relating to improvements in a **U-Shape And/or Nozzle U-Loop Fermenter And Method Of Fermentation**, filed as International Application Number PCT/DK2009/000250 on December 11, 2009 claiming benefit of Danish Application Number PA 2008 01780 filed September 15, 2008, published in English on June 24, 2010 under International Publication Number WO 2010/069313 A1 and that entered the US National Stage under Application No. 13/139,501 and was published October 6, 2011 under US Patent Application Publication No. US 2011/0244543; and all the rights and privileges under any and all Letters Patent that may be granted therefor and including any and all patents issuing from continuation, divisional, and reissue applications, and including the right to collect any and all damages past and future.

The assignor requests that any and all patents for said inventions be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.


The assignor agrees that, when requested, the assignor will, without charge to said assignee but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in any and all countries and for vesting title thereto in said assignee, its successors, assigns and legal representatives or nominees.

The assignor authorizes and empowers the said assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said inventions filed by it or them, the benefit of the right of priority provided by: (a) the International Convention for the Protection of Industrial property, as amended, or by convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any


treaty which may henceforth be substituted for it; and to invoke and claim such right of priority without further written or oral authorization from the assignor.

The assignor hereby consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the said assignee or nominee to claim the aforesaid benefit of the right of priority provided by: (a) the International Convention for the protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it.

The assignor covenants with said assignee, its successors and assigns and legal representatives, that the rights and property herein conveyed are free and clear of any encumbrance, and that I have full right to convey the same as herein expressed.
