AND, I hereby bind myself, my heirs, legal representatives, administrators and assigns properly to execute without further consideration any and all applications, petitions, oaths and assignments or other papers and instruments which may be necessary in order to carry into full force and effect, the sale, assignment, transfer and conveyance hereby made or intended to be made and generally do everything possible to aid **EMORY UNIVERSITY's** legal

representatives and assigns, to obtain and enforce proper protection for said invention in all countries throughout the world.
