#### PARTIES

- (1) Jake Dyson LLP, a Limited Liability Partnership (registered no OC361359) whose registered office is at 1 Crawford Passage, London, EC1R 3DP (Assignor);
- (2) Dyson Technology Limited, a private company (registered no 1959090) whose registered office is at Tetbury Hill, Malmesbury, Wiltshire, SN16 0RP (Assignee); and
- (3) Jacob Dyson whose address is at 1 Crawford Passage, London, EC1R 3DP (Jacob Dyson)

#### BACKGROUND

- (A) The Assignor and Jacob Dyson are between them the registered proprietors of all the Rights (as defined below);
- (B) Where Jacob Dyson is the registered proprietor of any of the Rights, he holds those rights as trustee for the Assignor.
- (C) By the Main Agreement (as defined below), the Assignor has agreed to sell and transfer, and Dyson Exchange Limited has agreed to buy, the Business (comprising the Assets) as a going concern on the terms and conditions set out in the Main Agreement and by virtue of the Main Agreement the Assignor has agreed to assign the Rights to the Assignee.

#### AGREED TERMS

##### 1. INTERPRETATION

- 1.1 The following words and expressions used in this Assignment shall have the following meanings, unless the context requires otherwise:

**Business:**

the business of the design, manufacture, marketing, promotion and sale of Products by or on behalf of the Assignor, as carried on at the Effective Time.

**Designs:**

means the registered designs and applications for registered designs set out in Schedule 1.

**Effective Time:**

00:01 in London on the date of completion of the Main Agreement.

**Intellectual Property:**

means patents, rights in inventions, rights in designs, copyrights and moral rights, rights to use and protect the confidentiality of confidential information (including know-how and trade secrets), and any other intellectual property rights, in each case whether registered or unregistered (and including applications for registration), and all rights or forms of protection having equivalent or similar effect which subsist or will subsist, now or in the future, anywhere in the world.

**Know How:**

means product technology, specifications, manufacturing techniques and other know how relating to the Products, which are owned by the Assignor and/or Jacob Dyson.

**Main Agreement:**

means the asset purchase agreement made on or about the date of this Deed of Assignment relating to the business and assets of "Jake Dyson Products".

**Patents:**

means the patents and patent applications set out in Schedule 2.

**Products:**

means engineered lighting products.

**Rights:**

means all Intellectual Property which is used by the Assignor in connection with the Business (other than in connection with the marketing, promotion and sales functions of the Business) and which is owned by the Assignor and/or Jacob Dyson (whether alone or with any other person), including for the avoidance of doubt the Patents, Designs and Know-How.

1.2 In this Assignment, unless the context otherwise requires:

- (a) the headings are inserted for convenience only and shall not affect the construction of the Assignment;
- (b) references to one gender shall include all genders;
- (c) references to the singular shall include the plural and vice versa;
- (d) any words following the terms "including", "include" or any similar expression shall be construed as illustrative and shall not limit the sense of the words preceding those terms.

1.3 The Schedules comprise schedules to this Assignment and form part of this Assignment.

**2. ASSIGNMENT**

2.1 In consideration of the Main Agreement, each of the Assignor and Jacob Dyson hereby assigns to the Assignee absolutely, with full title guarantee, their entire respective right, title and interest in and to the Rights, together with all goodwill and statutory and common law rights attaching to the Rights and including the right to sue for damages and other remedies for infringement or misuse of the Rights which may have occurred prior to the date of this Assignment and to retain those damages.

**3. WARRANTIES**

3.1 The Assignor hereby warrants as follows:

- (a) Complete and accurate particulars of all registered Rights including applications for such rights are set out in Schedules 1 and 2. All Rights are used exclusively in connection with the Business.
- (b) No party other than the Assignor or Jacob Dyson has any right, title or interest in or to any of the Rights.
- (c) The Rights are valid, subsisting and enforceable, and nothing has been done or not been done as a result of which any of them has ceased or might cease to be valid, subsisting or enforceable. In particular:
  - (i) all application and renewal fees and other steps required for the maintenance or protection of such rights have been paid on time or taken;
  - (ii) all confidential information (including Know-How and trade secrets) owned or used in connection with the Business has been kept confidential and has not been disclosed to third parties (other than parties who have signed written confidentiality undertakings in respect of such information); and
  - (iii) there are and have been no claims, challenges, disputes or proceedings, pending or threatened, in relation to the ownership, validity or use of such rights.
- (d) There has been no infringement by any third party of any Rights, nor any third party breach of confidence, passing off or actionable act of unfair competition in relation to the Business and no such infringement, breach of confidence, passing off or actionable act of unfair competition is current or anticipated.
- (e) The execution and performance of this agreement will not result in the termination of, or materially affect, any Rights or of any licences relating to any Rights.

#### 4. FURTHER ASSURANCE

- 4.1 The Assignor and Jacob Dyson shall, at the Assignee's cost, sign all documents and do all things which may be required by law or which the Assignee may reasonably request from time to time (including executing as soon as reasonably practicable after the date of this Assignment all documents which the Assignee may reasonably require to effect the registration or recordal of the assignment of the Rights to the Assignee in any relevant jurisdiction) by way of further assurance of the rights assigned under this Assignment.

#### 5. SEVERABILITY

- 5.1 If any provision of this Assignment is held to be invalid or unenforceable, then the provision shall (so far as it is invalid or unenforceable) be given no effect and shall be deemed not to be included in this Assignment but without invalidating any of the remaining provisions of this Assignment.

6. COUNTERPARTS

6.1 This Assignment may be entered into in any number of counterparts and by the parties to it on separate counterparts, each of which is an original but all of which together constitute one and the same instrument.

7. RIGHTS OF THIRD PARTIES

7.1 A person who is not a party to this Assignment shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any of its terms.

8. ENTIRE AGREEMENT

8.1 This Assignment (together with the documents referred to in it) constitutes the entire agreement between the parties in relation to the assignment of the Rights and supersedes any previous agreement between the parties in respect of the same.

9. GOVERNING LAW AND JURISDICTION

9.1 This Assignment and the relationship between the parties shall be governed by, and interpreted in accordance with, English law.

9.2 Each of the parties agrees that the courts of England are to have exclusive jurisdiction to settle any disputes (including claims for set off and counterclaims) which may arise in connection with the creation, validity, effect, interpretation or performance of, or the legal relationships established by, this Assignment or otherwise arising in connection with this Assignment, and for such purposes irrevocably submits to the jurisdiction of the English courts.
