### RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "Release"), dated as of October 23, 2015, is made by MB Financial Bank, N.A., as successor in interest to Cole Taylor Bank ("Lender"), in favor of M & R Printing Equipment, Inc. ("Grantor"). Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Loan Agreement or the Patent Security Agreement.

WHEREAS, the Patent Security Agreement was recorded at the United States Patent and Trademark Office on November 11, 2010 at Reel/Frame 025347/0042; and

WHEREAS, Lender has agreed to terminate and release its security interest in all such Collateral, as provided in the Loan Agreement and the Patent Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender agrees as follows:

- 1) Release of Security Interest. Lender hereby relinquishes, terminates, discharges and releases to the Grantor, any and all right, title and interest, including any security interest, it may have or have acquired through the Loan Agreement and the Patent Security Agreement in the Collateral (together with all of the goodwill associated therewith or symbolized thereby).
- 2) Further Acts. Lender hereby authorizes and requests that this Release be recorded at the United States Patent and Trademark Office, or any other applicable location. Lender shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at the Grantor's cost and expense, to more fully and effectively effectuate the purposes of this Release.
- 3) <u>Full Authority</u>. Lender represents and warrants that it has full authority to execute and deliver this Release.
- 4) <u>Governing Law</u>. THIS RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
