Assignor further agrees that he or she will, without further consideration: (i) promptly disclose to Assignee's patent attorney any prior art known to Assignor during the pendency of the Application or other US or foreign related applications; (ii) testify in any legal or administrative proceeding and participate in any examiner interview relating to the inventions or improvements described in or subject of the Application; and (iii) provide reasonable assistance to the Assignee to obtain and enforce proper patent protection for the inventions and improvements described in or subject of the Application.

This assignment and all disputes under this assignment shall be governed by the laws of the Commonwealth of Massachusetts. Any and all claims, lawsuits, or disputes of any kind between Assignor and Assignee shall be resolved in federal or state courts in the Commonwealth of Massachusetts.

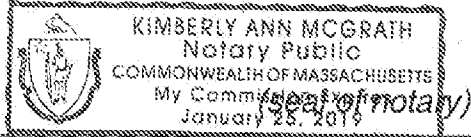


