AND the Assignor agrees to sign and execute any further documents which may be necessary or desirable, lawful, and proper in connection with the prosecution of all PATENTS AND PATENT APPLICATION and all interference proceedings associated therewith, or otherwise necessary or desirable to secure the title thereto to the Assignee, to execute all papers and documents and to perform all lawful acts which are necessary in connection with claims to priority or otherwise; and to perform all lawful


affirmative acts which are necessary to obtain the grant of a valid and enforceable patent to the Assignee;

AND for the same consideration, the Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of the entire right, title, and interest in and to said PATENTS AND PATENT APPLICATION, and that the Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.


