REQUEST FOR CORRECTED NOTICE OF RECORDATION

It has been brought to our attention that the "Patent Assignment Cover Sheet" filed on March 31, 2015 in connection with the above-identified application contains the following errors:

1. The cover sheet actually relates to a "Release of Security Interest". It was entitled as a "Patent Assignment Cover Sheet" by error.
2. The cover sheet correctly lists the two Receiving Parties listed benefitting from the Release of Interest:

MIRION TECHNOLOGIES, INC.
MIRION TECHNOLOGIES (IST) CORPORATION

The cover sheet also correctly lists the six properties (patents and patent applications) released, but fails to distinguish which property is released to whom. Each piece of listed property is owned individually by one of the Receiving Parties.

The Release of Security Interest returns each piece of listed property to the hands of its individual owner.

-> Incorrectly, the "Patent Assignment Cover Sheet" filed on March 31, 2015 does not detail which property belongs to which Receiving Party. This caused all six properties to be incorrectly registered as being assigned commonly to both Receiving Parties.

The assignment record must be corrected to reflect which property belongs to which Receiving Party, as follows:

US Patent Application Numbers: 12/936,357 and 13/326,215 are owned by and assigned to "Mirion Technologies, Inc." only; and

US Patent Application Number: 12/999,613 and US Patent Numbers 6,202,486; 6,667,761 and 7,184,076 are owned by and assigned to "Mirion Technologies (IST) Corporation" only.

To resolve the foregoing issues, we enclose two separate Release of Security Interest Recordation Cover Sheets (one for each Receiving Party), marked to show the amendments made with respect to the "Patent Assignment Cover Sheet" filed on March 31, 2015 and we also enclose a copy of the original Releases of Security with the recordation cover sheet as filed on March 31, 2015; and a copy of the Notice of Recordation of Assignment Document dated November 23, 2015.

It is respectfully requested that the assignment recordal information be promptly corrected as indicated.

RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this "Release") is made as of March 31, 2015 ("Effective Date") by Credit Suisse AG, Cayman Islands Branch, as administrative agent (herein, in its capacity as administrative agent, "Grantee"), in favor of Mirion Technologies, Inc., a Delaware corporation and Mirion Technologies (IST) Corporation, a New York corporation (herein, each a "Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Patent Security Agreement (as defined below), or if not defined therein, in the Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below).

WHEREAS, Grantee, as administrative agent, the Issuing Banks, the Syndication Agent, the Borrower and the Lenders entered into a Credit Agreement dated as of March 30, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") pursuant to which, among other things, the Revolving Lenders extended Revolving Commitments to make the Revolving Loans to the Borrower, the Issuing Banks agreed to issue Letters of Credit for the account of the Borrower and/or its subsidiaries and the Term Lenders agreed to make the term Loans to Borrower;

WHEREAS, in connection with the Credit Agreement, each Grantor executed and delivered a Pledge and Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") dated March 30, 2012.

WHEREAS, pursuant to the terms of the Credit Agreement and Section 11(d) of the Security Agreement, each Grantor granted to Grantee for the benefit of Grantee and the other Secured Parties a continuing security interest in all of the Patent Collateral (as defined below) of such Grantor to secure the Secured Obligations;

WHEREAS, each Grantor executed and delivered the certain Patent Security Agreement, dated March 30, 2012 (the "Patent Security Agreement"), which was recorded at the United States Patent and Trademark Office at Reel/Frame 027959/0495 and 027959/0464 on March 30, 2012;

WHEREAS, pursuant to the Patent Security Agreement, each Grantor pledged and granted to Grantee for the benefit of the Secured parties a security interest in all of such Grantor's right, title and interest, whether then owned or thereafter acquired by such Grantor and wherever located, in and to any and all of the following:

(a) all patents and patent applications, and the inventions and improvements described and claimed therein, and patentable inventions and the reissues, divisions, continuations, renewals, extensions and continuations-in-part of any of the foregoing (including, without limitation, those patents and patent applications listed in Schedule I), together with all rights associated with the foregoing, including, without limitation, all

rights to sue and otherwise recover for any past, present or future infringement, or other violations of any of the foregoing, and all corresponding rights throughout the world; and

(b) all proceeds of the foregoing (including, without limitation, royalties, income and payments) (clauses (a) and (b) collectively, the "Patent Collateral").

WHEREAS, Grantee acknowledges full performance of the Secured Obligations and accordingly has agreed to release its security interest granted and recorded against the Patent Collateral, and to reconvey any and all rights in the Patent Collateral to the applicable Grantor.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (a) terminates, cancels, releases and discharges its continuing security interest in all of Grantors' right, title and interest in, to and under Patent Collateral, and (b) re-assigns to such Grantor any and all right, title or interest it may have in such Patent Collateral, all without warranty and representation of any kind.

Grantee shall, at Grantors' sole cost and expense, and without representation or warranty, take all further actions and provide to each Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York, without reference to conflicts of law provisions.
