ASSIGNMENT OF INTELLECTUAL PROPERTY

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this “**Assignment**”), dated as of December 24, 2015 (the “**Effective Date**”), is entered into by and between JBS Ansembourg Holding S.à r.l., a Luxembourg private limited liability company (*société à responsabilité limitée*) with a share capital of USD 20,004, having its principal office located at 6 rue Jean Monnet, L-2180 Luxembourg, Grand-Duchy of Luxembourg and registered with the Luxembourg Register of Commerce and Companies (*R.C.S. Luxembourg*) under number B 202.222 (the “**Assignor**”), and JBS Luxembourg S.à r.l., a Luxembourg private limited liability company (*société à responsabilité limitée*) with a share capital of USD 20,006, having its principal office located at 6 rue Jean Monnet, L-2180 Luxembourg, Grand-Duchy of Luxembourg and registered with the Luxembourg Register of Commerce and Companies under number B 202.366 (the “**Assignee**”).

RECITALS:

WHEREAS, Assignor is the owner of the entire right, title, and interest in and to the patents, patent applications, and all reissues, extensions, divisions, continuations, and continuations-in-part thereof, that are described in detail on Exhibit A annexed hereto (the “**Patents**” or the “**Assigned Intellectual Property**”); and

WHEREAS, Assignor wishes to assign to Assignee, and Assignee desires to acquire, the entire right, title, and interest in and to the Assigned Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and Assignee do hereby agree as follows:

1. ASSIGNMENT. Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns and legal representatives, the entire right, title, and interest, including the right to sue for past, present, and future infringement and to collect for all past, present and future damages, in and to the Assigned Intellectual Property.

2. FURTHER ACTIONS. Assignor hereby covenants and agrees to execute and deliver, at the request of Assignee, such further instruments of transfer and assignment and to take any other action as such Assignee may reasonably request to more effectively consummate the assignments contemplated by this Assignment. Assignor agrees to execute, acknowledge and deliver such further documents, instruments, conveyances and assurances and to take such further actions as may be reasonably required to register in the name of Assignee the assignment of the Assigned Intellectual Property in any appropriate governmental agency or registrar.

3. MISCELLANEOUS.

3.1. Governing Law. This Assignment shall be governed by and construed in accordance with the domestic laws of the State of New York without giving effect to any choice or conflict of law provision or rule (other than sections 5-1401 and 5-1402 of the New York General Obligations Law) that would cause the application of the laws of any jurisdiction other than the State of New York.


3.2. Counterparts/Amendments. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same instrument. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment. This Assignment may only be amended, modified or supplemented by an agreement in writing signed by the Assignor and the Assignee.




