**TERMINATION AND RELEASE OF  
GRANT OF A SECURITY INTEREST – PATENTS AND TRADEMARKS**

THIS TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST – PATENTS AND TRADEMARKS (this “Termination”), dated as of December 1, 2015, is executed by Pacific Western Bank, as successor in interest by merger to Square 1 Bank (the “Bank”), in favor of DVTEL, Inc (“INC”) and DVTEL, LLC (“LLC”) (INC and LLC may be referred to collectively herein as the “Grantor”). All initially capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the INC IP Security Agreement (defined below).

**RECITALS**

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of April 30, 2013, executed by INC in favor of Bank (the “INC IPSA”), INC granted to Bank a security interest in the IP Collateral (defined below).

B. Pursuant to that certain Intellectual Property Security Agreement, dated as of April 30, 2013, executed by LLC in favor of Bank (the “LLC IPSA”), LLC granted to Bank a security interest in the IP Collateral (defined below).

C. Pursuant to that certain Supplement to Intellectual Property Security Agreement dated as of August 6, 2014, executed by INC in favor of Bank (the “INC IP Supplement”), INC granted to Bank a security interest in the IP Collateral (defined below).

D. The INC IPSA was recorded with the United States Patent and Trademark Office (the “USPTO”) on June 19, 2013, at Reel/Frame 030661/0033 (with respect to patents) and at Reel/Frame 5052/0091 (with respect to trademarks) to evidence the security interest granted under the INC IPSA.

E. The INC IP Supplement was recorded with the USPTO on September 19, 2014 at Reel/Frame 5366/0049 (with respect to trademarks) to evidence the security interest granted under the INC IP Supplement.

F. Bank agrees to execute this Termination in order to evidence the termination and release of its security interest in the IP Collateral specified below.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby agrees as follows:

(a) Bank expressly terminates and releases all of Bank’s right, title and interest in, to and under the following (collectively, the “IP Collateral”):

(i) all Patents of the Grantor, including without limitation those set forth on Schedule 1 hereto, and all rights corresponding thereto throughout the world and all re-issues, divisionals, continuations, renewals, extensions, and continuations-in-part thereto;

(ii) all Patent Licenses of the Grantor in connection with the Patents described in clause (i) above;

(iii) all Trademarks of the Grantor, including without limitation those set forth on Schedule 2 hereto, and all rights corresponding thereto throughout the world; and

(iv) all income, royalties, proceeds and liabilities due or payable, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof, except to the extent received by Bank prior to the date of this Termination in accordance with the terms of the INC IPSA, the LLC IPSA, and the INC IP Supplement.

(b) Bank represents and warrants that it has the full power and authority to execute this Termination.

(c) Bank authorizes and requests the USPTO to record this Termination.


