ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (the "Agreement") is entered into by and between Acer Incorporated of Taipei, Taiwan, R.O.C. (the "Assignor") and CMC Magnetics Corp. of Taipei, Taiwan, R.O.C. (the "Assignee"), and shall be effective on the 21st day of December 2015.

WITNESSETH:

WHEREAS, the Assignor owns fifty percent (50%) of the right, title and interest in patents as set forth in Exhibit I of this Agreement (the "Patents");

WHEREAS, the Assignor wishes to assign its fifty percent (50%) of the right, title and interest in the Patents to the Assignee (the "Assigned Rights"); and

WHEREAS, the Assignee wishes to accept such assignment of the Assigned Rights on the terms and conditions set out hereinbelow;

NOW THEREFORE, the parties hereto agree as follows:

ARTICLE I. ASSIGNMENT.

- (a) The Assignor hereby assigns, conveys and transfers to the Assignee the Assigned Rights, and the Assignee hereby accepts such assignment of the Assigned Rights. For the avoidance of doubt, the Assigned Rights include the right to claim for loss and damages, both in the past and future, in connection with the Patents.

- (b) In consideration for the foregoing assignment of the Assigned Rights, the Assignee will assume the obligations as set forth in the "LD 專利所有權讓與合約書(LD Patent Assignment Agreement)". The receipt and sufficiency of such consideration are hereby acknowledged.


