ASSIGNMENT OF INVENTION

WHEREAS, I, **Jos MEULEMAN**, Talmalaan 9, Bennebroek NL-2121 CR, the Netherlands, the undersigned, have invented certain new and useful improvements entitled **MECHANICAL LINKAGE**, for which a national phase patent application for Letters Patent the United States is being filed based upon international patent application number PCT/EP2014/0563681 filed on March 28, 2014, which claims priority to British patent application 1305984.5 filed on April 3, 2013;

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to me in hand paid, the receipt of which is hereby acknowledged, I hereby assign, sell, and transfer unto said Moog BV my entire right, title, and interest in said improvements, said application, and all divisional, continuing, substitute, renewal, reissue, and all other applications for Letters Patent which have been or shall be filed in the United States and all foreign countries on any of said improvements; and in and to all original and reissued patents which have been or shall be issued in the United States and all foreign countries on said improvements; and in and to any and all priority rights, rights under the International Convention For The Protection Of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto.


And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said Moog BV as the assignee of my whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid improvements, as the assignee thereof shall hereafter require and prepare at its own expense.
