**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, without representation, warranty or recourse, hereby terminates and releases its security interest in the Patents and Patent Applications, including, without limitation, the patents identified on Schedule A attached hereto, effective as of the date set forth above.


The Secured Party acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
