RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) is made as of January 5, 2016 (“Effective Date”) by and between **TPG SPECIALTY LENDING, INC.**, a Delaware corporation, (the “Assignee”), as Administrative Agent, and **AESYNT B.V. (formerly known as Aesynt Topco B.V.)**, a private limited liability company organized under the laws of The Netherlands (the “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement by and between Grantor and Assignee dated as of May 8, 2014 (the “Patent Security Agreement”), Grantor granted to Assignee a continuing security interest in and to all of Grantor’s right, title and interest in, to and under all of the patents and patent applications owned by Grantor (collectively, the “Patents”), including, without limitation, the patents and patent applications set forth on Schedule A attached hereto;

WHEREAS, Grantor and Assignee entered into the Patent Security Agreement pursuant to the terms and conditions of (i) that certain Guarantee and Collateral Agreement, dated as of May 8, 2014 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “***Guarantee and Collateral Agreement***”), among the Assignee, the Grantor, and certain of the Grantor’s affiliates, and (ii) that certain Credit Agreement, dated as of May 8, 2014 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the “***Credit Agreement***”), between, among others, certain of the Grantor’s affiliates, the Assignee, and certain Lenders party thereto;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on May 21, 2014, at Reel/Frame 032981/0671; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby terminates the Patent Security Agreement, the Guarantee and Collateral Agreement, and the Credit Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Patents.

Assignee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Patents; (iii) it has not recorded or otherwise evidenced its security interest with respect to any patent or patent application owned by Grantor, other than those of the foregoing patents set forth on Schedule A (attached hereto), in any jurisdiction throughout the world other than such filings made in the PTO.

Assignee shall, at Grantor’s expense, take all further actions, and provide to Grantor, Grantor’s successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
