I agree that I will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain patents for


said inventions and for additions and modifications thereto in any and all countries, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.
