RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE (this "Patent Release") is made as of January 5, 2016 from Wells Fargo Bank, National Association, as Administrative Agent for the Lenders (in such capacity, the "Administrative Agent"), for the Beneficiaries (as defined in the Credit Agreement referred to below) to MTS Medication Technologies, Inc. (the "Grantor"). Unless otherwise defined herein, terms defined in the Credit Agreement and used herein have the meaning given to them in the Credit Agreement.

WHEREAS, MTS Medication Technologies, Inc. entered into that certain Credit Agreement dated as of September 25, 2013, and Supplemented on January 20, 2014 and February 6, 2015 (said Credit Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Credit Agreement") in favor of Wells Fargo Bank, National Association, as Administrative Agent for the Lenders;

WHEREAS, the Credit Parties may from time to time enter, or may from time to time have entered, into one or more Secured Cash Management Agreements and Secured Hedge Agreements in accordance with the terms of the Credit Agreement; and

WHEREAS, Grantor executed and delivered that certain Subsidiary Guaranty Agreement dated as of September 25, 2013 (said Subsidiary Guaranty Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Guaranty") in favor of the Administrative Agent for the benefit of the Secured Parties;

WHEREAS, pursuant to the terms of a Collateral Agreement dated as of September 25, 2013 (said Collateral Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Collateral Agreement"), among Grantor and the Administrative Agent, Grantor created in favor of the Administrative Agent a security interest in, and the Administrative Agent became a secured creditor with respect to, the Patent Collateral;

WHEREAS, in connection with the Collateral Agreement, the Grantor executed that certain Patent Security Agreement dated September 25, 2013 (as the same may be or may have been amended, restated or amended and restated, supplemented or otherwise modified from time to time, the "Grant of the Patent Security Interest") pursuant to which the Grantor granted to the Administrative Agent, for the benefit of the Lenders, a security interest in (i) all rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all patents and patent applications and rights and interests in patents and patent applications under any domestic or foreign law that are presently, or in the future may be, owned or held by such Grantor and all patents and patent applications and rights, title and interests in patents and patent applications under any domestic or foreign law that are presently, or in the future may be, owned by such Grantor in whole or in part (including, without limitation, the patents and patent applications set

forth on Schedule A annexed hereto), all rights (but not obligations) corresponding thereto to sue for past, present and future infringements and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof; and (ii) all proceeds, products, rents and profits of or from any and all of the foregoing Patent Collateral and, to the extent not otherwise included, all payments under insurance (whether or not the Administrative Agent is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Patent Collateral. For purposes of this Grant of Patent Security Interest, the term "proceeds" includes whatever is receivable or received when Patent Collateral or proceeds are sold, licensed, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary (the "Patent Collateral");

WHEREAS, the Patent Security Agreement was recorded in the U.S. Patent and Trademark Office on September 27, 2013 at Reel/Frame No. 031301/0958 in favor of the Administrative Agent;

WHEREAS, the Patent Security Agreement was recorded in the U.S. Patent and Trademark Office on January 21, 2014 at Reel/Frame No. 032100/0731 in favor of the Administrative Agent;

WHEREAS, the Patent Security Agreement was recorded in the U.S. Patent and Trademark Office on October 31, 2014 at Reel/Frame No. 034080/0488 in favor of the Administrative Agent;

WHEREAS, the Patent Security Agreement was recorded in the U.S. Patent and Trademark Office on February 6, 2015 at Reel/Frame No. 034909/0898 in favor of the Administrative Agent;

WHEREAS, the Administrative Agent now desires to terminate, release and reassign the entirety of any security interest it may have in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby terminates, cancels, releases, discharges, and reassigns to Grantor, any security interest it may have in the Patent Collateral. The Security Agent agrees, at the Borrower's expense, to cooperate with, and to provide the Borrowers, their successors, assigns or other legal representatives with, the information and additional authorization necessary to effect the release of any security interest it may have in the Patent Collateral.
