## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement is entered into as of December 18, 2015 by and between the Grantors listed on the signature page hereto (collectively, the "**Grantor**") and **SILICON VALLEY BANK ("SVB")**, as Security Agent for the benefit of the Secured Parties (in such capacity, the "**Security Agent**").

### RECITALS

A. SVB has agreed to make certain advances of money and to extend certain financial accommodations (the "**Loans**") to Grantor and certain affiliates of Grantor in the amounts and manner set forth in that certain £2,000,000 and \$47,000,000 Multicurrency Term and Revolving Facilities Agreement, dated December 18, 2015 (as amended, amended and restated, supplemented, restructured or otherwise modified or renewed from time to time, the "**Facilities Agreement**"), by and among **THE FOUNDRY MIDCO NO 2 LIMITED**, a company registered under the laws of England & Wales (the "**Parent**"), **THE FOUNDRY BIDCO LIMITED**, a company registered under the laws of England & Wales (the "**Company**"), **THE FOUNDRY GROUP LLC**, a California limited liability company ("**Foundry LLC**"), **THE FOUNDRY USCO, INC.**, a Delaware corporation ("**Foundry Inc.**"), **MADE WITH MISCHIEF INC.**, a Delaware corporation ("**Made with Mischief**"); and together with Foundry LLC and Foundry Inc., each a "**U.S. Party**" and collectively, the "**U.S. Parties**"), the other "Original Borrowers" and "Original Guarantors" listed on Schedule 1 to the Facilities Agreement, SVB, as Lender, and SVB, as the Security Agent. Unless otherwise defined herein, capitalized terms shall have the respective meanings given to such terms in the Collateral Agreement (as defined herein).

B. In consideration of the agreement by SVB to make the Loans under the Facilities Agreement, the Grantors have entered into that certain Collateral Agreement in favor of the Security Agent, dated as of December 18, 2015 (as the same may be amended, modified or supplemented from time to time, the "**Collateral Agreement**").

C. Pursuant to the terms of the Collateral Agreement, Grantor has granted to the Security Agent a security interest in all of such Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its Secured Obligations under the Facilities Agreement and Finance Documents, Grantor hereby represents, warrants, covenants and agrees as follows:

### AGREEMENT

To secure its Secured Obligations under the Facilities Agreement and the Collateral Agreement, Grantor grants and pledges to the Security Agent, for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in, to and under its Collateral constituting Intellectual Property (including without limitation those Copyrights, Patents, and Trademarks listed on Exhibits A, B, and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to the Security Agent under the Collateral Agreement. The rights and remedies of the Security Agent with respect to the security interest granted hereby are not intended to be greater than those set forth in the Collateral Agreement and shall not be deemed to modify or expand and right, title or interest of the Security Agent under the Collateral Agreement. Each right, power and remedy of the Security Agent provided for herein or in the Collateral Agreement, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by the Security Agent of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement and the Collateral Agreement, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including the Security Agent, of any or all other rights, powers or remedies. In the event of any conflict between the terms of this Intellectual Property Security Interest and those of the Collateral Agreement, the terms of the Collateral Agreement shall control.

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.


