Assignor warrants that he is the exclusive owner of the entire legal and equitable interest in the Patent and the invention disclosed therein, free and clear of all liens and encumbrances; and that he has full power, authority, and capacity to make this Assignment to Assignee. Assignor covenants and agrees, for himself and for his successors and assigns that, at Assignee's

request, Assignor will cause to be executed and delivered any applications, affidavits, assignments, and other instruments as may be deemed necessary or desirable by Assignee to secure for or vest in Assignee, its successors or assigns, all right, title, and interest in and to any application, patent, or other right or property covered by this Assignment, including the right to apply for and obtain patents in foreign countries under the provisions of the International Convention; and Assignor hereby requests and authorize the United States Commissioner of Patents and Trademarks to issue any and all United States patents granted on the Patent to Assignee as owner of the entire right, title, and interest in and to the same, and authorize appropriately empowered officials of foreign countries to issue any letters patent granted on the Patent to Assignee as owner of the entire right, title, and interest in and to the same.
