## AGREEMENT ON THE ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

This Agreement is made and entered into on 22 July 2013 ('the Effective Date') by and between:

### PREAMBLE

- Assignor is the owner of and has the right to certain Intellectual Property Rights related to

*'Method and system for identifying and handling (tracing/locating/identifying to receive services) an owner and items in a secure/private Area'*

As listed hereafter ('the Assets'):

- **US patent granted under number 8,334,753 B2 (filing number 12/224,164).**

- Assignor wishes to transfer and Assignee wishes to acquire the entire rights, title and interest in the Assets.

### 1. Transfer

- 1.1. Assignor agrees to sell, transfer and assign and Assignee agrees to purchase and accept on the terms stated herein, all of the Assignor's right, title and interest in and to the Assets.
- 1.2. Assignor agrees to execute any documents that may be required in connection with the transfer, prosecution and maintenance of the Assets, including additional documents that may be required to affirm the rights of Assignee in and to such Assets, all without further consideration.

- 3.1. This Agreement comprises the entire agreement and understanding between the Parties and supersedes all previous understandings or agreements prior to the Effective Date of the Agreement regarding the substance of this Agreement.
