

7. The Inventors certify that
 - a. The Inventors are the sole four inventors of the Invention and that the Inventors have the full and absolute right to assign the Invention to ExThera AB.
 - b. None other than ExThera AB or the Inventors has claimed a (full or partial) right to the Invention.
 - c. There is no dispute whatsoever concerning the Invention (including the right to the Invention).
8. The Assignee has the right to transfer this Agreement - wholly or in part - without restrictions.

BEKRÄFTELSE AV ÖVERLÄTELSE AV UPPFINNING

1. Undertecknade uppfinnare ("Uppfinnarna") har den 25 september 2007 överlätit till ExThera AB, 556650-2745 ("ExThera AB"), all sin rätt i hela världen till en uppfinning ("Uppfinningen") benämnd "Device and method for restoration of the condition of blood", vilken uppfinning beskrivs i Europeisk patentansökan nr EP07110460.8.
2. Överlåtelsen ovan inkluderar rätten att för egen räkning söka och erhålla patent eller annat immaterialrättsligt skydd i Sverige och utomlands.

 - a. Uppfinnarna är de enda fyra uppfinnarna till Uppfinningen och att Uppfinnarna har haft full och oinskränkt rätt att överläta Uppfinningen till ExThera AB.
 - b. Ingen annan än ExThera AB eller Uppfinnarna har ställt krav på att ha rätt (helt eller delvis) till Uppfinningen.
 - c. Ingen tvist föreligger avseende Uppfinningen (innehållande rätten till Uppfinningen).
