AN ASSIGNMENT BETWEEN

NEIL HARGREAVES, of British nationality, c/o ROCK SOLID IMAGES PLC, 30 Aylesbury Street, London, EC1R 0ER, United Kingdom, (hereinafter referred to as "Inventor HARGREAVES"); and

SVEN TREITEL, of US nationality, c/o ROCK SOLID IMAGES INC, 2600 South Gessner, Suite 650, Houston, Texas, 77063, USA (hereinafter referred to as "Inventor TREITEL"); and

ROCK SOLID IMAGES PLC, a company incorporated and registered in England and Wales with registration number 4329960 whose registered office is at 30 Aylesbury Street, London, EC1R 0ER, United Kingdom; and

ROCK SOLID IMAGES INC, a corporation existing under the laws of the State of Delaware, USA with a place of business at 2600 South Gessner, Suite 650, Houston, Texas, 77063, USA

WHEREAS :-

(A) Inventor HARGREAVES and Inventor TREITEL claim jointly with each other to have made the Invention described in the Schedule (hereinafter referred to as "the Invention");

(B) The invention has been made by Inventor HARGREAVES during the performance of services provided by Inventor HARGREAVES pursuant to a consultancy agreement between Inventor HARGREAVES and ROCK SOLID IMAGES PLC and in accordance with the terms of the consultancy agreement Inventor HARGREAVES agrees to assign all his rights in the Invention including the right to apply for a patent or patents relating to the Invention to ROCK SOLID IMAGES PLC together with all rights title and beneficial interest in and arising therefrom.

(C) The invention has been made by Inventor TREITEL during the performance of services provided by Inventor HARGREAVES pursuant to a consultancy agreement between Inventor TREITEL and ROCK SOLID IMAGES INC and in accordance with the terms of the consultancy agreement Inventor TREITEL agrees to assign all his rights in the Invention including the right to apply for a patent or patents relating to the Invention to ROCK SOLID IMAGES INC together with all rights title and beneficial interest in and arising therefrom.

(D) ROCK SOLID IMAGES PLC agrees to assign its rights to the Invention, the right to apply for a patent or patents relating to the said Invention, together with all rights title and interest in and arising therefrom to ROCK SOLID IMAGES INC.

NOW THIS AGREEMENT WITNESSES as follows:-

1. In pursuance of the agreement referred to in Recital (B) and IN CONSIDERATION of the sum of FIVE BRITISH POUNDS, receipt of which is hereby confirmed, Inventor HARGREAVES hereby assigns to ROCK SOLID IMAGES PLC the whole of his property in the Invention throughout the world and any protection obtained at any time therefor and all rights title and interest which Inventor HARGREAVES may have or have been entitled to therein including all rights to bring proceedings for infringement thereof together with the full and exclusive benefit thereof and the right to apply for and obtain or to enable others to apply for and obtain a patent or patents or any other form of protection in respect of the Invention both in the United States of America and throughout the world and to exploit the Invention or any patent or other protection obtained in respect thereof TO HOLD the same unto ROCK SOLID IMAGES PLC absolutely.

2. In pursuance of the agreement referred to in Recital (C) and IN CONSIDERATION of the sum of FIVE BRITISH POUNDS, receipt of which is hereby confirmed, Inventor TREITEL hereby assigns to ROCK SOLID IMAGES INC the whole of his property in the Invention throughout the world and any protection obtained at any time therefor and all rights title and interest which Inventor TREITEL may have or have been entitled to therein including all rights to bring proceedings for infringement thereof together with the full and exclusive benefit thereof and the right to apply for and obtain or to enable others to apply for and obtain a patent or patents or any other form of protection in respect of the Invention both in the United States of America and throughout the world and to exploit the Invention or any patent or other protection obtained in respect thereof TO HOLD the same unto ROCK SOLID IMAGES INC absolutely.

3. in pursuance of the Agreement referred to in Recital (D) and IN CONSIDERATION of the sum of FIVE BRITISH POUNDS, receipt of which is hereby confirmed, ROCK SOLID IMAGES PLC hereby assigns to ROCK SOLID IMAGES INC all its rights in the Invention including the right to apply for a patent or patents and to exploit the Invention or any patent or other protection obtained in respect thereof both in the United States of America and throughout the world TO HOLD the same unto ROCK SOLID IMAGES INC absolutely.

4.
