INVENTION, PATENT AND INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Invention, Patent and Intellectual Property Assignment Agreement is made this 08 day of January 2016 by and between Jennifer Morse ("Assignor", previously known as Jennifer Rose Rivera Velasquez), an individual whose address is 648 Loma Drive, Hermosa Beach, CA 90254, and Made Simpli, LLC, a California limited liability company, whose address is 648 Loma Drive, Hermosa Beach, CA 90254 ("Assignee"):

WHEREAS, Assignor is or was an employee, contractor, or other service provider to Assignee; and

WHEREAS, Assignor participated in the development of inventions, which are the subject of but are not limited to the U.S. Patent Application tentatively titled "Infusion Process Apparatus and Method", which is a Continuation-in-Part of U.S. Application No. 14/593643, filed on January 9, 2015 and entitled "Infusion Extracting Apparatus and Method," which claims the benefit of Provisional Application No. 61/964621, filed on January 10, 2014. The inventions are generally described as equipment and methods for use in a beverage making process; and

WHEREAS, Assignor and Assignee desire to confirm the assignment to Assignee of all present and future rights, title, and interest to the Inventions, including all rights, title, and interest in patent, copyright, trade secret, trademark and other proprietary rights embodied in, evidenced by or otherwise described in the Inventions (collectively "IP Rights");

NOW, THEREFORE, for good and valuable consideration of the mutual promises herein and one dollar in hand paid, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign and transfer unto Assignee, its successors and assigns, and automatically assigns and transfers in the future, the entire right, title and interest in and to all IP Rights in the Inventions, including but not limited to all derived patents as that term is understood within the meaning of **35 USC § 291(a)**, patent divisions, re-issues, continuations or continuations-in-part, substitute patent applications, and extensions thereof, in the United States and anywhere in the world, (including but not limited to the right to apply for Letters Patents in foreign countries in the Assignee's own name and to claim any priority rights for such foreign applications to which such applications are entitled under international conventions, treaties, or otherwise).
2. Assignor does further agree to execute and deliver without further consideration any further applications, assignments and documents, and to perform such other acts as Assignee lawfully may request, that may be deemed necessary by Assignee, its successors, assigns and nominees, fully to secure Assignee's interest as aforesaid and to obtain or maintain Letters Patents in any and all countries. If Assignor fails, refuses or is otherwise unable to execute such documents, the Assignor hereby appoints any other Member of the Assignee with the power of attorney to execute such documents and take such acts under this paragraph as Assignor was required to execute or take, such power being coupled with an interest herein and irrevocable.
3. Assignor does hereby authorize and request the Commissioner of Patents and, in the event foreign patent applications are filed, the heads of the foreign patent granting entities where foreign patent applications are filed, to reflect on the public record ownership in the Assignee of the entire right, title and interest in the Inventions.




