ASSIGNMENT

WHEREAS, I,

Michael Schlosser, an Israeli citizen residing at 51 She'arit Hapleita Street, 34987 Haifa, Israel

Hereinafter referred to as Assignor, have made the invention having the title:


**"GUIDING MEANS FOR ADMINISTERING ACUPUNCTURE AND OTHER HEALING PROCEDURES"**

For which Israeli Patent Application No. 227374 was filed on July 8, 2013; And a PCT International Patent Application No. PCT/IL2014/050587 was filed on July 1, 2014.

AND WHEREAS, MS GOOD ENERGIES LIMITED, a Cyprus company of 7 Florinis Str., Greg Tower, 2nd Floor, 1065 Nicosia, Cyprus hereinafter referred to as Assignee, is desirous of acquiring all right, title and interest in and to said invention and the aforementioned patent application, except for Guatemala, and in any patent that may be granted therefor in all countries, except Guatemala.

NOW, THEREFORE, in consideration of One US Dollar (\$ 1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, we, the Assignors, hereby sell, assign and set over to said Assignee the entire and exclusive right, title and interest for Israel and all other countries of the world except Guatemala in and to said invention and the aforesaid patent application, and all rights to file, under the Paris Convention, and any other convention, patent applications based thereon and all divisional or other applications and patents applied for or granted therefor in Israel and in any other country excluding Guatemala (hereinafter "patent(s) or "patent application(s)"), including all US national derivatives, and all patents which may be granted thereon and including international patent applications filed according to the Patent Cooperation Treaty (PCT) and all national / regional phase applications which will derive from the PCT applications except Guatemala, and all patents which may be granted thereon, and the undersigned for me and my legal representatives, heirs and assigns do hereby agree and covenant without further remuneration, to execute and deliver all documents required for transferring said patents / applications to said Assignee or its assigns, to communicate to said Assignee or its representatives all facts known to the undersigned with respect to said patents / applications, whenever requested, to testify in any legal proceedings in which the said patent applications may become involved, to sign all lawful papers, make all rightful oaths, and to do generally everything necessary to aid said Assignee, its successors, assigns and nominees to register the assignment of the said Patent Applications, the expenses incident to said applications to be borne and paid by said assignee. The terms of this Deed of Assignment prevail over any other assignment or other deed, if any previously made in respect of the same matters.

I further confirm that said assignment has from 1 July, 2014 been of full force and effect in relation to Canada.
