THEREFORE, in consideration of Ten Dollars and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby irrevocably transfer to Assignee, Assignors' entire right, title, and interest in and to the described inventions and the Patents, including, without limitation, any continuations, continuations-in-part, divisionals, extensions, reissues, substitutions, utility models, designs, and any other intellectual property protections, claims or grants of rights which may have been, may be now, or in the future may be filed, obtained, derived, claim priority to, be based on, or be asserted for the Patents and any of their described inventions (collectively, "Property"); all in any country or countries; together with any past, present or future claims, causes of action and rights to compensation related to the Property, and the right to file such patents and claim all possible priority rights derivable from the Property under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, any other international agreement, and the laws of any country, reserving no rights to Assignors.

Assignors agree, promise, and warrant that Assignors have the full right to convey Assignors' transferred interests; have not executed, and will not execute, any agreement in conflict with this Agreement; Assignors will communicate to Assignee all facts known to Assignors relating to the Property, to the best of Assignors' current actual knowledge; Assignors will testify in any legal proceeding related to the Property, sign all lawful papers, execute all declarations and divisional, continuation, continuation-in-part, reissue, and any other similar applications, make all rightful oaths, communicate, confer, and cooperate with Assignee, and do everything useful to help Assignee perfect its

interest in and obtain and enforce all protections potentially deriving from the Property in all countries and to exclusively obtain all benefits therefrom. Assignors agree that at Assignee's election, after giving or attempting to give notice to Assignors, Assignee may delegate any person to execute as Assignors' agent any documents useful for these purposes.


Assignors authorize and request the Commissioner for Patents of the United States, and any officials of any countries or international agencies, whose duty it is to receive or issue patents or other forms of intellectual property protection, to issue same to Assignee in accordance with this agreement.

This Agreement will be governed by and construed in accordance with Texas law, excluding its choice of law provisions. This is the entire agreement between the parties concerning its subject matter. It will be interpreted and construed in accordance with its fair meaning and not for or against either party.




