AND said ASSIGNOR hereby agrees to execute all papers necessary to file applications in the United States for said Letters Patent and to assign the same to said ASSIGNEE, or any assignee acquiring title to said Letters Patent, and to execute any other papers at ASSIGNEE'S sole cost and expense that may be needed in connection with securing further Letters Patent thereon.


