PATENT SECURITY AGREEMENT

GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS AND PATENTS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Sovereign Software LLC, a Delaware limited liability company, (the "**Grantor**"), hereby grants, on this 8th day of January 2016, to S Funding LLC (the "**Grantee**"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States patents (the "**Patents**") set forth on Schedule A attached hereto together with (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) of the Marks and Patents.


THIS GRANT is made to secure the full and prompt performance and payment of all the Obligations (as such term is defined in the Security Agreement described herein). Upon the termination of the Security Agreement or as otherwise provided in Section 7 of the Security Agreement, the Grantee shall, upon such satisfaction, execute, acknowledge, and deliver to the Grantors an instrument in writing releasing the security interest in and re-assigning the Marks and Patents acquired under this Grant to the Grantor.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement among the Grantor, the other assignors party thereto and the Grantee, dated as of January 8, 2016 (as amended, amended and restated or otherwise modified from time to time, the "**Security Agreement**"). The rights and remedies of the Grantee with respect to the security interest granted herein are more fully set forth in the Security Agreement. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
