RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of January 13, 2016, by COMERICA BANK, a Texas banking association ("Bank") in favor of TELARIX, INC., a Delaware corporation ("Grantor") with its principal place of business located at 1950 Old Gallows Road, Suite 800, Vienna, VA 22182.

Recital

WHEREAS, in connection with that certain Third Amended and Restated Loan and Security Agreement between Grantor and Bank and dated as of June 26, 2012 (as amended, modified, supplemented and restated from time to time, the "Loan Agreement"; capitalized terms used but not defined herein shall have the respective meanings set forth in the Loan Agreement), Grantor granted to Bank a security interest in certain Copyrights, Trademarks and Patents, including the patents and trademarks described on Exhibits A and B attached hereto (collectively, the "Intellectual Property"), in accordance with the terms of the Intellectual Property Security Agreement dated as of June 28, 2011 as amended from time to time (the "Security Agreement"), which was recorded with the US Patent and Trademark Office on June 28, 2011 at reel 026513; frame 0707 with respect to patents, and at reel 4571, frame 0225 with respect to trademarks.

WHEREAS, Grantor has no outstanding obligations to Bank under the terms of the Loan Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby, (i) terminates the Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Intellectual Property, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Intellectual Property.
