## PATENT TRANSFER AGREEMENT

12 February 2015 (the "Effective Date")

### BY AND BETWEEN

**ON THE ONE PART, GRIFOLS WORLDWIDE OPERATIONS LIMITED**, a company duly incorporated and existing under the laws of Ireland, having its registered address at Embassy House, Herbert Park Lane, Ballsbridge, Dublin 4 (Ireland) ("GWO"); and

**ON THE OTHER PART, GRIFOLS, S.A.**, a company duly incorporated and existing under the laws of Spain, having its registered address at Calle Jesús y María, nº6, 08022-Barcelona (Spain) ("Grifols SA").

Hereinafter, GWO and Grifols SA shall be collectively referred to as "Parties" and individually as a "Party".

### WHEREAS


- I. GWO holds all rights, title and interests in and to the Spanish patents P201331177/X, P201430343/6, P201430824/1, P201430843/8 and P201431561/2, European Patent 14162919.6 and US patents 14/283.571 and 14/250.034 (the "Patents").
- II. Due to Grifols SA's patent policy, the Parties have agreed that GWO shall transfer its ownership over the Patents to Grifols SA, together with any and all interest and rights derived thereof.
- III. Therefore, both Parties, mutually recognizing, in the representation they hold, their necessary legal capacity for this act, enter into this Patent Transfer Agreement (the "Agreement") in accordance with the following

### CLAUSES

1. GWO hereby transfers, assigns, conveys and delivers to Grifols SA and Grifols SA hereby accepts such transfer, assignment, conveyance and delivery of all of GWO's rights, title and interests in and to the Patents, included any possible applications related thereto and all renewals and extensions thereof.
2. GWO hereby covenants and agrees that, upon Grifols SA's prior written request, it shall execute and deliver any document that Grifols SA may reasonable require or need for the purpose of evidencing, enforcing, protecting and/or defending Grifols SA's rights, title and interests in and to the Patents.
3. In consideration for the transfer of the Patents, Grifols SA shall pay to GWO the total amount of €40,032 (VAT not included), which amount corresponds to the costs already assumed by GWO related to each of the Patents up to the Effective Date.

4. The indicated amount shall be paid by Grifols SA to GWO within thirty (30) days of receipt of the invoice issued by GWO, through bank transfer to the bank account designated by GWO.
5. The invoice issued by GWO shall include a breakdown of the applicable VAT, as well as the amounts to be paid by Grifols SA per each Patent.
6. This Agreement shall enter into force on the Effective Date and continue until both Parties fulfil all obligations contained herein.
7. The Parties agree that this Agreement is a commercial agreement on the terms of the provisions contained herein, and shall be governed by the laws of Spain, excluding any principles of conflicts of law.
8. Any dispute, controversy or difference arising out of or in connection with this Agreement shall be settled by Arbitration in Law before the *Tribunal Arbitral de Barcelona*, which shall be in charge of appointing one (1) arbitrator, expert on the purpose of this Agreement, and of managing the proceeding, pursuant to its own rules and regulations. The award rendered by the arbitrator shall be final and binding upon the Parties hereto.
