## ASSIGNMENT



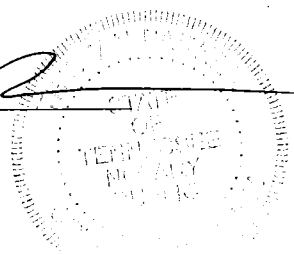

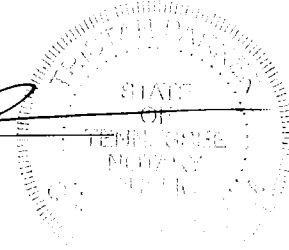
