

application for Letters Patent, and Letters Patent issued and granted as a result thereof, testify in any legal proceedings, sign all lawful papers, execute all divisions, continuations, continuations-in-part, substitutions, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said WILLIAMSON in accordance with the twenty-five percent (25%) interest provided herein, make all rightful oaths, and generally do everything necessary or desirable to aid said WILLIAMSON and his successors and assigns to obtain and enforce proper protection for the said invention and application in the United States of America and all of its colonies and territorial possessions and in any and all foreign countries.

Further, HARTMAN agrees that this agreement shall be binding upon the parties hereto, their heirs, executors, administrators, successors and assigns.
