AND I HEREBY AUTHORIZE AND REQUEST the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States for said invention, resulting from any of the aforesaid applications to said UNVER S.P.A., as sole ASSIGNEE, unless another assignee is subsequently timely, lawfully and properly identified.
