ASSIGNMENT OF PATENT RIGHTS
(Company to Company)

Swimways Corporation, a corporation duly organized under and pursuant to the laws of the Commonwealth of Virginia, and having its principal place of business at 5816 Ward Court, Virginia Beach, VA 23455 (herein referred to as "Assignor") owns the entire right, title and interest in the Invention as defined in the Assignment and Royalty Agreement (defined below) including any Letters Patent(s) ("said patent(s)") and any Patent application(s) ("said application(s)") set forth in Attachment A of this Assignment of Patent Rights.

WHEREAS, an Assignment of Intellectual Property and Royalty Agreement was entered into on January 1, 2011 (herein referred to as "the Assignment and Royalty Agreement") between Assignor and Island Shade Shacks, Inc., a corporation duly organized under and pursuant to the laws of California, and having its principal place of business at 22921 Triton Way, Suite 231, Laguna Hills, CA 92653 (herein referred to as "Assignee");

WHEREAS, Assignor has elected to convert the Assignment and Royalty Agreement to a non-exclusive license pursuant to Section 9(b) of the Assignment and Royalty Agreement;

WHEREAS, Assignor acknowledged in Section 9(d) of the Assignment and Royalty Agreement that, if Assignor elected to convert the Assignment and Royalty Agreement to a non-exclusive license pursuant to Section 9(b) of the Assignment and Royalty Agreement, Assignor would re-assign or assign the intellectual property rights in the Invention, including said patent(s) and said application(s) to Assignee.

NOW, THEREFORE, pursuant to Section 9(d) of the Assignment and Royalty Agreement, the Assignor by these presents does sell, assign, transfer, and set over, unto the Assignee, its successors, legal representatives, and assigns the entire right, title, and interest in and to the Invention, and to all trademarks, copyrights, patent applications, Letters Patent, divisions, continuations, continuations-in-part, substitutions, reissues, reexaminations, interferences and extensions related to the Invention, together with the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringement of the Invention.

AND for the same consideration, the Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of the entire right, title, and interest in and to said invention(s), said application(s), and said patent(s), and that the same are unencumbered, and that the Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND for the same consideration, the Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns that the Assignor will, whenever counsel of the Assignee, or the counsel of its successors, legal representatives, and assigns, shall advise that any proceeding in connection with the Invention, said application(s), said patent(s), any application claiming priority to said application(s), any reissue or extension of said patent(s), and any United States or foreign Letters Patent or Patents for the Invention or said application(s), including interference proceedings, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent or Patents for the Invention, without charge to the Assignee, its successors, legal representatives, and assigns, but at the cost and expense of the Assignee, its successors, legal representatives, and assigns;

AND the Assignor hereby requests the Commissioner of Patents to issue any and all aforementioned patent(s) of the United States to the Assignee, as the Assignee of the Invention and the Letters Patent to be issued thereon for the sole use and behalf of the Assignee, its successors, legal representatives, and assigns.


