ASSIGNMENT

Jaber hereby sell, assign and transfer to the Assignees, each Assignee receiving a fifty percent interest, all of my rights, title and interest in and to said invention, patent applications and patent rights throughout the world, including foreign patent priority rights, the right to file and prosecute International Applications under the Patent Cooperation Treaty, and the right to file and prosecute applications under the European Patent Convention; said invention, patent applications and letters patent in this or any foreign country, and all corresponding non-provisional applications, divisions, continuations, continuations-in-part, reissues and extensions thereof, to be held and enjoyed by the Assignees, for their own use and benefit, and for their successors and assigns to the full end of the term for which letters patent may be granted by the United States or any foreign country, as fully and entirely as the same would have been held by me had this assignment and sale not been made, and covenant that I have full right so to do, and agree that I will communicate to the Assignees, or its successors and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute

all divisional, continuing and reissue applications, make all rightful oaths, and do everything possible to aid the Assignees, their successors and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.

I confirm that at the time the invention was made, I was under an obligation to assign the invention to the Assignees.

I hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.


