THIS DEED is made the 16 day of JANUARY 2015

BETWEEN:-

- (1) MARTIN ROY HARRISON, a British citizen, of 15 Broad Lane, Evenley, Brackley, Northhamptonshire, NN13 5SF, United Kingdom; PHILIP SAMUEL PICKLES, a British citizen, of 4 Cumnor Hill, Botley, Oxford, Oxfordshire, OX2 9HA, United Kingdom, and ANN WHERRITT, a British citizen, of 39 Cherrytree Close, Southmoor, Abingdon, Oxfordshire, OX13 5BE, United Kingdom, personal representative for PETER WHERRITT (deceased) (hereinafter called "the Inventors" which expression where the context so allows shall include their personal representatives and assigns); and
- (2) SALUNDA LIMITED, a company incorporated under the laws of England and Wales, and having its registered office at Unit 14A Oddington Grange, Weston-on-the-Green, Bicester, Oxfordshire, OX25 3QW, United Kingdom (hereinafter called "the Company" which expression where the context so allows shall include its successors and assigns).

WHEREAS

- (A) The Inventors claim to be joint inventors of an invention relating to "Sensing Using a Marginal Oscillator" ("the Invention") full particulars of which have been communicated by them to the Company and which they are informed is or is intended to be the subject of one or more applications for patent protection initially as identified in the Schedule hereto and in respect of which they have (as they hereby acknowledge) approved a specification as submitted to them by the Company's Patent Attorneys, J A Kemp.
- (B) The Inventors each made their contribution to the Invention while in the employment of the Company and in the course of their normal duties or in the course of duties falling outside their normal duties but specifically assigned to them and the circumstances were such that an

invention might reasonably be expected to result from the carrying out of their duties and accordingly all their right title share and interest in and to the Invention is to be taken (as between them and the Company) to belong to the Company for the purposes of the Patents Act 1977 and for all other purposes of whatsoever nature.

(C) The Inventors have agreed at the request of the Company to execute this Deed on the terms herein contained

NOW THIS DEED WITNESSES as follows:

1. In pursuance of the said agreement and in consideration of the premises the Inventors HEREBY JOINTLY AND SEVERALLY and to the extent of their respective shares and interests therein ASSIGN and CONFIRM unto the Company ALL THOSE their respective right title share and interest in and to the Invention and the patent applications identified in the Schedule hereto and all patents granted thereon AND the full and exclusive benefit thereof TOGETHER WITH all rights of action and powers accruing or belonging to the Inventors AND the full right to apply for and obtain a patent or patents or other similar forms of protection in respect of the Invention in the United Kingdom of Great Britain and Northern Ireland and the Isle of Man (hereinafter called "the United Kingdom") and in all other countries of the world including the benefit of any priority date and the right to make applications whether under any national law or under the International Convention for the Protection of Industrial Property or under any other applicable convention or treaty TO HOLD the same unto the Company absolutely.

2. The Inventors HEREBY JOINTLY and SEVERALLY COVENANT and AGREE with the Company as follows:-

(a) that they will at any time hereafter (whether or not they remains in the employ of the Company) and from time to time at the request and expense of the Company promptly execute and sign all such instruments applications and documents and do all such acts

and things as may be required by the Company to enable the Company to enjoy the full benefit of the rights hereby confirmed and assigned including applying for and obtaining a patent or patents or other similar forms of protection in respect of the Invention in the United Kingdom and in all other countries of the world and vesting the same in the Company or its nominees when obtained;

(b) that they have not assigned or agreed to assign to any person firm or company or otherwise encumbered and will not hereafter assign or agree to assign to any person firm or company or otherwise encumber the Invention or the said patent applications or the right to apply for or obtain a patent or patents or other similar forms of protection in respect thereof in the United Kingdom or elsewhere throughout the world;

(c) that they will give to the Company all such information in their possession or in their power relating to the Invention and the method of using or employing the same as the Company shall require; and

(d) that they have not disclosed and will not hereafter without the written consent of the Company disclose the Invention or any information whatsoever concerning the same to any person firm or company other than the Company and its Patent Attorneys, J A Kemp.

3. This document shall be governed by and construed in accordance with English Law.
