right to sue for patent infringement, and any copyright in any embodiment of an Invention and any derivative right thereof,

(hereinafter collectively "Invention Rights").

Each Assignor covenants and agrees that this Assignment and all the terms thereof shall inure to the benefit of the successors, assigns, legal representatives, and nominees of Assignee, without further written or oral authorization from such Assignor.


Each Assignor further hereby represents and warrants that Assignor is an original inventor of the Invention; and such Assignor has reviewed and understood the contents of the Patent Properties.

This Assignment is governed by and shall be construed in accordance with the laws of North Carolina.


