## **RELEASE OF SECURITY INTEREST IN PATENT RIGHTS**

**THIS RELEASE OF SECURITY INTEREST IN PATENT RIGHTS** (this “Release”) is made as of January 4, 2016 (“Effective Date”) from JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent (the “Agent”) pursuant to the Amended and Restated Credit and Guarantee Agreement, dated as of April 25, 2006 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Lear Corporation as the Borrower and the other parties thereto, to Lear Corporation EEDS and Interiors, a Delaware corporation, located at 21557 Telegraph Road, Southfield, MI 48033 (the “Grantor”).

**WHEREAS**, the Grantor is party to that certain Security Agreement, dated as of April 25, 2006, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, the Grantor and the Agent entered into that certain Grant of Security Interest in Patent Rights, dated as of April 25, 2006 (the “Patent Security Agreement,” all capitalized terms used, but not defined, herein have the definition assigned to them in the Patent Security Agreement);

**WHEREAS**, pursuant to the terms and conditions of the Patent Security Agreement, the Grantor pledged and granted to the Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under the Patents (including, without limitation, those items listed on Schedule A hereto) (collectively, the “Collateral”); and

**WHEREAS**, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on June 23, 2006 at Reel 017833, Frame 0198.

**NOW, THEREFORE**, without recourse and without representation and warranty and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Collateral, and (ii) terminates the Patent Security Agreement with respect to such Collateral. For the avoidance of doubt, all payment obligations under the Security Agreement and the Credit Agreement shall remain in full force and effect.

The Agent shall take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantor to more fully and effectively effectuate the purposes of this Release.

The Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks to record this Release.


