PATENT ASSIGNMENT

This PATENT ASSIGNMENT (the "Assignment") is entered into as of this 4th day of February, 2016 (the "Effective Date") by and among Ghassan S. Kassab, an individual having a principal address at 2505 Hidden Valley Place, La Jolla, CA 92037 ("GSK"), Jose A. Navia, Sr., an individual having a principal address at Suipacha 1308, Apt. 4B, Buenos Aires, 1011, Argentina ("JAN"), and CVDevices, LLC, a limited liability company having a principal address at 11107 Roselle Street, San Diego, CA 92121 ("CVD"). GSK, JAN, and CVD may be individually referred to herein as a "Party" or collectively referred to herein as the "Parties."

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignment of Patents and/or Patent Applications. GSK and JAN (collectively the "Assignors") each hereby irrevocably assign, transfer, and convey to CVD all of their respective right, title, and interest in, to, and under the inventions and patent applications and/or patents set forth in EXHIBIT A attached hereto and hereby incorporated by reference herein, including, without limitation, (i) all inventions and improvements disclosed therein, (ii) all letters patent or similar legal protection granted therefor in the United States, its territorial possessions, and in all foreign countries, unions, or regions, (iii) all continuations, divisions, continuations-in-part, substitutions, reissues, renewals, substitutes, and extensions thereof and applications therefor, in the United States and its territorial possessions and in all foreign countries, unions, or regions, (iv) any and all patents and patent applications that claim priority to any of the foregoing, and (v) all rights to enforce including, but not limited to, the right to sue and collect damages for any past or future infringements throughout the world (the "Assigned Patents").

2. Filing and Recording Instruments of Transfer. CVD, at its sole discretion, shall make all filings with the requisite intellectual property offices in order to confirm, effectuate, or record this Assignment of the Assigned Patents to CVD granted herein. CVD shall be responsible to file and record any and all documents of conveyance as may be necessary to vest in CVD, as a matter of public record, all of the Assigned Patents.

3. Appointment. The Assignors hereby constitute and appoint CVD, and its successors and assigns, the true and lawful attorney or attorneys in fact of the Assignors, with the full power of substitution, for it and in its name and stead or otherwise, to institute and prosecute from time to time, any proceedings at law, in equity, or otherwise, that CVD, or its successors or assigns, may reasonably deem proper in order to assert or enforce any claim, right, or title of any kind in and to the Assigned Patents, and to defend and compromise any and all actions, suits, or proceedings, in respect to any of the foregoing, and generally to do any and all such acts and things in relation thereto as CVD, or its successors or assigns, shall reasonably deem advisable, including, but not limited to, the execution and delivery of any and all assignments and instruments in furtherance hereof. The Assignors declare that the appointment hereby made and the powers hereby granted are coupled with an interest and shall be irrevocable by the Assignors.

4. Miscellaneous. This Assignment shall be governed, construed, and enforced in accordance with the laws of the State of Indiana, without regard to any state's choice of laws to

the contrary. This Assignment shall inure to the benefit of, and be binding upon, the Parties hereto and their respective successors and assigns. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original and together shall constitute one in the same instrument. Facsimile copies of any signature to this Assignment shall be deemed an original signature hereto.


