**DOES HEREBY CERTIFY THAT:**

**FIRST:** The Board of Directors (the "Board") of Vonage Business Solutions, Inc. (the "Corporation"), pursuant to a Unanimous Written Consent of the Board dated December 18, 2015, duly adopted the following resolution setting forth a proposed amendment to the Fifth Amended and Restated Certificate of Incorporation of the Corporation, as amended, declaring such amendment to be advisable. The resolution setting forth the proposed amendment is as follows:

**RESOLVED**, that the Fifth Amended and Restated Certificate of Incorporation of the Corporation, as amended, shall be amended by deleting the text of Article First thereof and by substituting in lieu of such text the following:

**"FIRST:** The name of the corporation is Vonage Business Inc."

**SECOND:** Pursuant to the provisions of Section 242(b)(1) of the DGCL, no meeting or vote of stockholders is required to adopt said amendment.

**THIRD:** The amendment was duly adopted in accordance with the provisions of Section 242 of the DGCL.

**FOURTH:** This Certificate of Amendment is to become effective as of 12:01 a.m., Eastern Standard Time, on January 1, 2016.
